Do you feel forsaken?

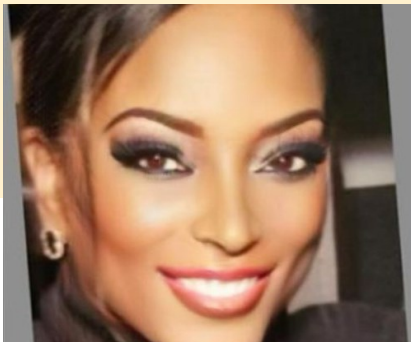

### Intensive Outpatient Program M-F 10am—1pm

A level of care treatment program for consumers who are referred from a medical institution, that is intense and very structured to help recreate a framework for the consumer and acclimate them back into society.

This 6-week program is comprised of nine (9) hours a week which includes individual therapy, group meetings, didactics, peer recovery and care of coordination. Transportation is available.

### Outpatient Program

A lower level of care program that is comprehensive and addresses mental illness and addiction and meets state requirement for medication assisted treatment program includes:

Weekly Therapy, 2 groups, and NP as needed. Transportation NOT available.

3. NO weapons No alcohol NO drugs or paraphernalia

5. NO smoking inside Smoking breaks allowed & supervised. CAN NOT LEAVE PREMISES
6. Upon completion of intake clients will be escorted to waiting area to meet with a counselor/therapist
7. Sexual harassment is grounds for dismissal
8. No congregating NO urinating or defecating except in bathroom ONLY!
9. Violation of any rule is grounds for suspension and/or dismissal from group and/or the program.
